

## CONSENT FOR CREATION AND PUBLICATION OF PHOTO AND FILM RECORDINGS

In this context, IQM is responsible for the processing of your personal data within the meaning of the GDPR and process your data, such as photo/video, contact details and company data, related to you. We need your consent for such publication. Your consent is voluntary. You will not suffer any disadvantages if you do not give us your consent. If you do not want to be photographed/filmed, please notify IQM prior to your arrival at the SQA Conference, to ensure that we can take appropriate measures to avoid you being filmed or photographed in the first place.

Where you are being asked to be photographed, interviewed, or filmed for public relation purposes and you agree to do so, your acceptance to be photographed, interviewed, or filmed will be deemed consent for our use of the material for the public relations purposes.

You can revoke your consent at any time and without giving reasons to IQM, [privacy@meetiqm.com](mailto:privacy@meetiqm.com). The processing of your personal data until revocation remains lawful. Further information about the processing of your personal data, in particular your rights as a data subject, can be found in our privacy policy.

Recipients of your personal data are the respective providers of the social media channels, TUM and MQV. While making your personal data available on the Internet (on our website and the social media channels), data may be transferred outside the EU/EEA.

Information on the Internet is accessible worldwide and can be found using search engines and linked to other information, from which personality profiles about you can be created under certain circumstances. The recordings can be easily copied and further processed. There are specialized archiving services whose aim is to permanently document the state of certain websites on specific dates. This can mean that information published on the Internet can still be found elsewhere even after it has been deleted from the original site.

Your personal data will be deleted if you withdraw your consent or if the processing of your personal data is no longer necessary for the purpose of processing. In case a photo/video has been forwarded to TUM or MQV, IQM will immediately forward your withdrawal of your consent.
